

## TERMS OF REFERENCE (TOR)

### Assessment of Climate Action Plans on SRHR and GBV Prevention in Six Communities

#### 1. Background

MyLEGACY is implementing *Promoting Gender Sensitive Climate Change Actions for a Better Tomorrow (Kesho Njema)* to address how climate change disproportionately affects women and girls, particularly in relation to Sexual and Reproductive Health and Rights (SRHR) and Gender-Based Violence (GBV).

In Dar es Salaam, climate impacts—like water scarcity and extreme weather—worsen vulnerabilities for women and girls, increasing GBV risks and limiting access to healthcare. Despite clear evidence, SRHR and GBV are often excluded from climate planning, and women remain underrepresented in decision-making.

This assessment seeks to evaluate existing climate action plans in six selected communities to identify gaps and inform future strategies that integrate SRHR and GBV prevention.

#### 2. Objectives

##### Primary Objective:

Assess how well current climate action plans in six communities in Dar es Salaam integrate SRHR and GBV prevention.

##### Specific Objectives:

- Review plans for SRHR and GBV-related content.
- Identify gaps and weaknesses in integration.
- Gather stakeholder insights on climate-related SRHR and GBV challenges.
- Provide recommendations for improving future plans.

#### 3. Scope of Work

- Review climate action plans and relevant policy documents in six communities of Kinondoni District as will be indicated by the organisation.
- Conduct stakeholder consultations ( Schools management in 2 schools, LGA officials in 2 LGA service centres ( *serikali za mitaa*, and 2 community leaders).
- Identify climate-related risks impacting SRHR and GBV.
- Analyze gaps, overlaps, best practices, and opportunities.
- Produce a report with practical recommendations.

#### 4. Methodology

- Document review of local/national climate strategies.
- Review LGA climate change action plans
- Key Informant Interviews (KIIs) with stakeholders.
- Data analysis and synthesis for the final report.

## 5. Deliverables

- **Inception Report:** Methodology and work plan (within 1 week of contract).
- **Draft Report:** Preliminary findings and gaps.
- **Final Report:** Incorporating stakeholder feedback.
- **Presentation:** Summary of key findings and recommendations.

## 6. Timeline (6 Days Total)

- Inception & Planning – 0.5 day
- Data Collection – 2 days
- Analysis & Drafting – 3 days
- Validation & Finalization – 0.5 day

## 7. Qualifications

- Proven experience in climate change, SRHR, and GBV.
- Knowledge of Tanzanian policy and community context.
- Strong analytical and reporting skills.
- Experience working with Dar es Salaam communities.

The consultant will report to the Executive Director and provide regular updates throughout the assignment.
